1. Background of the Change

RHYTHM CO., LTD. (the "Company") hereby announces that it has confirmed there has been a change in the major shareholders and the largest shareholder, which is also a major shareholder, in accordance with the Report of Large Volume Holding (the Change Report) submitted by Mr. Kankuro Ueshima, one of the shareholders of the Company, on June 30, 2025. As a result, three joint holders including him no longer qualify as the major shareholders as of June 30, 2025, as the number of voting rights held by each of them has become less than 10% of the total voting rights of all shareholders.
